I agree that Hatfield Township shall have the right, at its discretion, to enforce rules of conduct and/or terminate my participation and/or use of the Park and its facilities for failure to act in conformance thereof, or for actions or conduct detrimental to or incompatible with the welfare, comfort, harmony or interest of the group or the Park as a whole.

I hereby grant Hatfield Township and any of the directors, commissioners, officers, members, agents and other representatives full authority to take whatever action, in their discretion, its determined to be necessary regarding my health, safety and welfare, and I fully release Hatfield Township and any of the directors, commissioners, officers, members, agents, and other representatives from any liability for such actions, as set forth herein.

SCHOOL ROAD PARK PAVILION

Please note the below rules, specific to pavilion use. Please make sure you and your group members adhere to these, and the general rules that govern the park system.

- Taking your food refuse with you when you leave the park will be appreciated.
- Please dispose of all paper litter, including litter on the floor and cold cigarette butts, in pavilion receptacles.
- ***Your hot charcoals should be left to cool. Be prepared to dispose of used coals from people before you. Cold coals may be placed in the pavilion receptacles.***
- Be considerate of other park users when playing music.
- Pavilion lights are operational dusk until 10 p.m. by turning the timer on. Please turn off lights when you leave by dialing the timer to "off."
- Alcoholic beverages are prohibited.
- Skateboarding in pavilion or on tables is prohibited.
- It is permissible to bring your own gas grill(s) or hibachi(s).
- There are electric outlets at the pavilion.
- The park has a water hydrant on the soccer field and the senior baseball field. A fountain is located at the path leading from the pavilion to the soccer field.
- Restrooms are portable toilet units.

Thank you for your part in protecting and preserving this facility.



PARK REGULATIONS

The following is a partial list of rules and regulations governing conduct in the Hatfield Township Parks System. A complete list of regulations may be obtained from the Hatfield Township Administration Building.

- Group Coordinators shall be responsible for the actions of their guests while on park property, and are responsible to see that the regulations are adhered to.
- Use only designated park entrances.
- No unauthorized vehicles on paved paths in park interior.
- No loitering or disturbing others.
- No intoxicating beverages or intoxicated persons allowed.
- No gambling.
- No dogs or pets allowed in School Road Park.
- No fireworks, firearms or bows & arrows allowed.
- No mini-bikes or snowmobiles allowed.
- No motorized vehicles allowed off of roadway.
- All vehicles must not exceed 15-MPH speed limit.
- Place trash, rubbish, and garbage in trash receptacles provided.
- No defacing or destroying of any park equipment.
- Do not harm animals living in the park.
- Do not damage or harm trees or plants in the park.
- Fires permitted in approved equipment only. **REPORT OTHER FIRES TO HATFIELD TOWNSHIP POLICE IMMEDIATELY BY DIALING 911.**
- No advertised gathering of persons allowed.
- No one allowed in park before sunrise or after sunset. Guests may enjoy lighted facilities within the School Road Park until 10PM, lighted ball fields until 11PM.
- No groups or parties in excess of 50 persons unless through prior approval of Hatfield Township.
- No golfing or golf practice allowed.

VIOLATION OF THESE RULES IS PUNISABLE BY FINES AND IMPRISONMENT.
