



**HATFIELD TOWNSHIP
RESOLUTION 09-25**

A RESOLUTION OF THE TOWNSHIP OF HATFIELD, MONTGOMERY COUNTY, PENNSYLVANIA, DECLARING THAT NO MEMBER OF THE BOARD OF COMMISSIONERS OF HATFIELD TOWNSHIP SHALL BE ENTITLED TO RECEIVE REIMBURSEMENT FOR EXPENSES FOR ATTENDING ANY CONVENTION, CONFERENCE, INSTITUTE, SCHOOL OR ANNUAL MEETING HELD BY THE COUNTY ASSOCIATION OF TOWNSHIP OFFICERS OR REIMBURSEMENT FOR EXPENSES FOR ATTENDING THE ANNUAL MEETING OF THE STATE ASSOCIATION OF TOWNSHIP OFFICERS OTHER THAN THOSE EXPENSES REQUIRED TO BE REIMBURSED BY THE FIRST CLASS TOWNSHIP CODE; REPEALING ALL INCONSISTENT RESOLUTIONS; CONTAINING A SAVINGS CLAUSE; AND CONTAINING AN EFFECTIVE DATE

WHEREAS, Section 611 of the Pennsylvania First Class Township Code, 53 P.S. Section 55611, provides in relevant part that Commissioners must be reimbursed by the Township Treasurer for certain expenses for attending a convention, conference, institute, school or the annual meeting held by the County Association of Township Officers; and

WHEREAS, Section 622 of the Pennsylvania First Class Township Code, 53 P.S. Section 55622, provides in relevant part that Commissioners must be reimbursed by the Township for certain expenses for attending the annual meeting of the State Association of Township Officers; and

WHEREAS, the Board of Commissioners has determined that it is in the best interests of Hatfield Township to declare that no member of the Board of Commissioners shall be entitled to receive reimbursement for expenses for attending any convention, conference, institute, school or annual meeting held by either the County Association of Township Officers or the State Association of Township Officers, other than those expenses required to be reimbursed by the First Class Township Code;

NOW, THEREFORE, be it, and it is hereby **RESOLVED** by the Board of Commissioners of Hatfield Township, Montgomery County, Pennsylvania, as follows:

Section I. No member of the Board of Commissioners of Hatfield Township shall be entitled to receive reimbursement from the Township for expenses for attending any convention, conference, institute, school or annual meeting of the County Association of Township Officers or the State Association of Township Officers, other than those expenses required to be reimbursed by the First Class Township Code.

Section II. All resolutions inconsistent with this Resolution are hereby repealed to the extent of the inconsistency.

Section III. The provisions of this Resolution are declared to be severable. If any provision of this Resolution is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Resolution, which are hereby declared to be in full force and effect despite the invalidity or unconstitutionality of any provision hereof.

Section IV. This Resolution is effective upon its legal adoption by the Board of Commissioners of Hatfield Township.
